PRESIDENT'S MESSAGE

Within the past 5 years, there has been an uptick of recent graduates that have entered the valuation profession in Boston and nationally. "There are all sorts of benefits to a real estate valuation career," said Appraisal Institute President Stephen S. Wagner, MAI, SRA, AI-GRS. "There's a demand for your services, you control your work schedule, you can own a business, there's solid earning potential, and you'll find a variety of complex and unusual assignments." The number of active real estate appraisers in the U.S. (as of Dec. 31, 2018) stood at 78,015, a decrease of 5% from year-end 2017. The average rate of decrease for the past five years has been approximately 2.6% annually. Declines are expected to continue due to retirements, fewer new people entering the valuation profession, economic factors, government regulation and greater use of data analysis technologies. That trend creates opportunities for the next generation of appraisers.

Appraisers play an essential role in the economy and the real estate industry by developing reliable and credible opinions of value for their clients. Appraisers offer risk mitigation to help ensure safety and soundness of the lending system. In addition to residential and commercial lending work, appraisers provide valuable services such as client counseling, litigation support, right-of-way and eminent domain work, taxation-related valuation and many other areas of specialization.

Appraisal Institute research shows that more than one-fifth of appraisers earn at least \$150,000 annually; another nearly one-fourth make at least \$100,000. Al research also shows that appraisers who have an Appraisal Institute designation earn an average of 26 percent more than their professional counterparts.

The Massachusetts and Rhode Island Chapter of the Appraisal Institute regularly hosts networking events that are attended by appraisers new to the profession and those that have been in the business for decades. Attending a networking event or attending in class Appraisal Institute education classes are a great opportunity to meet and socialize with appraisers. In April, a day-long class instructed by Sandra Adomatis, SRA, LEED in Warwick, RI which was titled "Valuation by Comparison" was held. I had the privilege of attending other courses taught by Sandra in Charlotte, NC during the Appraisal Institute's 2017 National Conference and therefore knew she was an excellent instructor and knew her stuff. The Warwick seminar she taught was no different; well presented, in depth knowledge of the topic matter, challenging students to move them forward in their profession and she handled questions with ease. This was the second year in a row that Sandra has kicked off the RI Branch Chapter's education offerings and I hope it is a tradition that continues.

Susan Kelley, SRA, the Vice Chair of this year's RI Branch leadership team, advised the group that the RI Realtors had agreed to support a piece of legislation that RI appraisers had long talked about, but did nothing about, dealing with the year's required after an assignment that appraisers are responsible for keeping those workfiles. With the support of those two organizations and the RI Branch Chapter, we all testified at both the House and Senate hearings. The House bill emerged from the Corporations Committee intact and was voted out of committee and then out of the House. The companion Senate bill 0259 has yet to emerge from committee. The RI Senate is holding many bills that have been heard but not come back to the respective committee for an up and out vote. Not too surprising, as the RI General Assembly session is in its last trimester and the horse trading between the two chambers becomes more intense and things get bogged down.

Looking to the future, we will have our second RI Branch meeting on June 19th at the Downtown Providence Marriott Hotel and we are working on tying it together with a social event.

New Al Book

A new Al book, The Valuation of Condominiums, Cooperatives, and PUDs," was published on May 8. The book examines the physical and ownership characteristics of condominiums, cooperatives and planned unit developments. The text also demonstrates how to analyze the local market, identify appropriate elements of comparison and apply relevant valuation techniques.

Membership Status Changes

Effective May 9, 2019, the Appraisal Institute **Board of Directors voted to eliminate the Temporarily Non-Practicing status**. The status existed in the Al Bylaws for the purpose of providing a lower dues/fee level to individuals who temporarily could not work due to certain circumstances such as poor health or physical disability; family obligation or responsibility; military service; or other good cause shown.

The status, typically granted for only up to one year with no renewal option, did not provide relief to an AI professional in need of ongoing financial relief. Furthermore, AI already has a dues/fee waiver process in place that grants an AI professional financial relief based on the same circumstances. (These same AI professionals may also be eligible for relief grants from the AIERF.) Designated members may request a dues waiver between January and September.

Designated members who wish to change their status may do so via the online Status Change Application. The various statuses—in additional to their respective descriptions of eligibility—are listed on Designated Member Status Changes webpage. Factors to Consider for Life Science Building Conversions

As the global biotech industry continues to mature and grow the levels of demand for lab space in metros like Boston have far outstripped the available supply for some time now. This is true especially in key life science clusters like Kendall Square in Cambridge. The resulting effects on local space market fundamentals continue to play out through the greater metro area.

Life science corporations favor vibrant, amenity-rich neighborhood with proximity to university resources as well as synergies that come with being proximate to similar companies, potential partners, and suppliers. Given the dearth of life science laboratory inventory in the established neighborhoods, tenants have been seeking lab space in the metro's more emerging life science clusters, like the Seaport, Waltham and Watertown. Landlords are responding to this ever-growing demand by constructing new lab space as well as converting traditional office and industrial space.

When considering existing real-estate for lab conversion, there are many factors to consider. The two most critical issues are:

- 1. Sufficient clear heights. Shell buildings considered suitable for potential lab conversions must typically have 14- to 15-foot interior clear heights. These additional areas are needed to provide additional HVAC and power systems to service exhaust vents.
- 2. Additional floor load requirements. Laboratory floors must be able to support 125 to 150 pounds per square foot for lab as opposed to 80 to 100 pounds for office.

Looking at costs, the core and shell retrofit expenses range from \$125 to \$150 per square foot with another \$125 to \$150 for specific tenant improvements over shell. The rental suites typically consist of 40% to 60% laboratory with the remaining space being traditional office area.

There are several other factors to keep in mind when considering converting offices into labs as well. First, laboratories require a redundancy of power and critical systems, support space for chemical storage, and PH neutralization systems. Many lab areas feature specialty suites such as vivarium's, and BL-1 and BL-2 chambers. Although the amount of office space per worker is declining, life science requires 350 to 550 square feet per employee compared to an average of 175 to 200 square feet for more traditional office workers. Depending on floor plates and the size of the building, this could limit a space's ability to attract tenants of a certain size.

Moreover, laboratories typically require 100% outside air at a rate of 1.5 cubic feet per minute (CFM) compared to more traditional office at a recommended ventilation rate is 20 CFM. The "minutes per air change" is a design value chosen for the type of space in buildings. Therefore, laboratory uses have substantially greater HVAC demand that office users. These systems are often housed in a rooftop mechanical penthouse with air vents.

It is worth citing a few notable urban and suburban buildings in the Greater Boston area which have been successfully converted – at least partially - to life science laboratories. Urban building examples include: 451 D Street in South Boston, 80 Guest Street in Brighton, and 645 Summer Street in South Boston. In the suburbs, 60 Sylvan Road in Waltham is being considered for conversion from office to lab. In the near future, Boston Properties is planning to retrofit 33 Hayden Avenue in Lexington, which was recently leased entirely to Dicerna Pharmaceuticals, and 200 West Street in Waltham into life science laboratories.

Although location is still key for life science users, the basic building criteria of interior clear height and floor load capacity are crucial factors in determining a building's life science retrofit suitability. Given the frenetic levels of lab demand in Greater Boston, expect landlords to continue to entertain these conversion projects where applicable.

Massachusetts and Rhode Island Chapter Board Votes to Support Two Massachusetts Bills

The Massachusetts and Rhode Island Chapter of the Appraisal Institute has moved to support two pieces of legislation currently pending at the Massachusetts State House.

Bill H.216 - An Act Defining Client, Intended Use and Intended User in Real Property Appraisal Assignments and Reports

This bill establishes a framework that limits the liability of an appraiser to the client and intended user only. The operative language is that the appraisal...'is deemed prepared at the request of and exclusively for the benefit of the appraiser's client or intended user, and for the intended use, as specified in the appraisal report or appraisal review report. An appraiser shall (i) not be liable in a court of law to any person other than the client or intended user; and (ii) not be subject to disciplinary action stemming from a complaint filed with the Division of Professional Licensure by any person other than the client or intended user.'

The perceived benefit of this legislation extends protections to appraisers by limiting exposure to litigation from unintended users of appraisal reports. The bill was sent to study last year as a way to delay action, but it is possible that it might make it out of committee this session.

Bill H.1114 - An Act Relative to Appraisal Management Companies

This bill establishes licensing requirements for appraisal managed companies (AMC). The bill as constituted appears to create a comparable board of licensing as currently exists with the traditional real estate appraisal board. The regulation as outlined of AMCs is consistent with the existing structure of appraisers in the Commonwealth. This legislation does not overstep the requirements set forth at the Federal level for AMCs which is the case some states. Further, Dodd Frank requires action on this matter by August 10, 2019.

The Board will review letters of support to be distributed to State Legislators support the Chapter's stance on these issues.
