New England Appraiser Expo in Review

This yearly event co-hosted with the MBREA was held virtually in 2020 John R. Drew, MAI, 2020 Vice President and Programs Chair

The MA-RI Chapter, in association with the MBREA, kicked off the 2020 edition of the New England Appraisers Expo on December 8th. Opening up on the 8th was Jessica Lautz, Ph.D. Vice-President of Demographics & Behavior Insights at the National Association of REALTORS[®] who provided provide an economic and demographic overview of the changing housing landscape and the new relationship we have with our homes in the current environment.

This year's virtual panels began with Let's Get Real About Implicit Bias featuring Bill Pastuszek, Jr. MAI, MRA, ASA as moderator, addressing the issue head-on with panelists Delisa Joseph, vice president and CRA officer for Needham Bank, Danyl Collings of Four Core Valuations, LLC, Nicole Rodriguez, Research Director, for the New Jersey Policy Perspective, also, Madison "Matt" Thompson, Board Chair of the Fields Corner Community Development Corporation, someone who has worked for over 40 years in the areas of conflict resolution, diversity, and cultural competency.

The commercial programs got underway on December 10th with a five person panel, moderated by John R. Drew, MAI, Manager of MassHousing's Appraisal & Marketing Department, addressing COVID-19: Fallout on the multi-family residential/mixed use TOD property sector. A group of seasoned professionals explored the impact COVID-19 has had on the multi-family sector in the Greater Boston/Massachusetts market area. The panelists provided their unique insights into the market dynamics addressing currents housing market trends, the impact of costs & delays, the future of public transportation, and the real time experience of a Transportation Oriented Development (TOD) that came on-line just as the COVID-19 pandemic broke. The panel featured Monica G. Tibbits-Nutt, AICP, LEED AP BD+C., Executive Director of the 128 Business Council and Massachusetts Department of Transportation (MassDOT) Board of Directors; Alexander Bross, RA, LEED AP, MassHousing's Manager, of Design & Construction; Sandi Silk, Senior Vice President/Development Partner for Jefferson Apartment Group; also, Adin Perera, Senior Market Analyst covering New England and Todd Galvin, Real Estate Analyst with the CoStar Group.

Rounding off day two of the Expo was a seasoned panel of experts addressing COVID-19's Impact on Tourism, Events, & Hospitality. The panel was moderated by Tom Jensen, MAI Executive Director of Boston Appraisal & Consulting and included an eye-opening discussion on the current conditions of some of the main drivers of the Greater Boston economy. The featured speakers included David Gibbons, Executive Director of the Massachusetts Convention Center Authority; Mike Jorgensen, Managing Director of the Omni Boston Hotel at the Seaport; Christopher P. Jamison, CEO of COJE Management Group Corp.; also, Jonathan Martin, Managing Director in Newmark Knight Frank Boston.



Remarks from 2020 National President Jeff Sherman, MAI, AI-GRS

On Thursday, December 3rd, the Chapter held its annual Installation of Officers, Directors, and Regional Reps. Like everything else in 2020, this event looked nothing last past years. The Chapter was pleased to welcome 30 AI Chapter Professionals and guests for a virtual Installation ceremony. Attendees were joined by special guest 2020 National President Jefferson Sherman, MAI, AI-GRS. Mr. Sherman outlined some of our major achievements of the Appraisal Institute in 2020 including:

- An improved relationship with The Appraisal Foundation which led to the two organizations co-sponsoring an event on December 9th entitled Promoting Trust for Fair and Affordable Housing."
- The organization completed a comprehensive research project on how to attract new members. This is an extremely exciting development that can successfully catapult the Appraisal Institute into the future by attracting new members.
- The Appraisal Institute's Find an Appraiser project team has been working at a fever pitch to improve AI's Find an Appraiser feature on it's website. Classroom and Virtual Education in 2021 Being Offered

For 2021, the Chapter's Education Committee will continue to offer in-person education as long as COVID-19 guidance allows. Check the Chapter website for any scheduling changes. Registered students will be notified of any changes as soon as possible. In order to meet social distancing guidelines, the Chapter is taking the following steps to ensure the safety of our students and instructors:

- Class size is limited. As restrictions are lifted/amended, the Chapter will adjust class size.
